Personal Statement

As a reminder, the personal statement is an essential component of the initial application stage. Therefore, success at this stage is dependent on your personal statement satisfying the requirements detailed below.

Please provide a personal statement between **400 and 600** words explaining how your personal attributes and qualities meet the wider criteria for being a Maths Scholar.

Specifically, your personal statement must cover each of the following four points:

- 1. Your motivation for pursuing a career as a mathematics teacher.
- 2. Your strategies for igniting the interest of secondary school students in mathematics.
- 3. Your reasons for aspiring to become a Maths Scholar.
- 4. Describe how your journey as a Maths Scholar will enhance your initial teacher training year

Important Information

- It's imperative to address all the points outlined above; failure to do so will result in the rejection of your application.
- Please be aware that any personal statement falling below the 400-word threshold will be rejected automatically.
- As this personal statement is specific to the Mathematics Teacher Training Scholarships, we require a minimum of 200 words to be dedicated to points 3 and 4, as listed above.
- For clarification, a Maths Scholar is an individual who has received a Mathematics Teacher Training Scholarship.
- The Maths Scholarships Team maintains the discretion to assess whether your personal statement aligns with the aforementioned criteria.

We strongly encourage you to incorporate any relevant experiences, such as school teaching or observations, employment, interactions with young people, volunteer work, as well as your interests and hobbies, to strengthen your application. However, when integrating these experiences, it's vital to establish a clear connection to how they have deepened your understanding of ways to inspire others with your passion and developed your insights into the teaching and learning of mathematics.

A well-considered personal statement, which fully addresses the requirements listed above, is a vital component in progressing to the next stage of assessment for the Mathematics Teacher Training Scholarship. Therefore, we strongly recommend dedicating ample time and effort to carefully craft your personal statement.*

Reasonable Adjustments

Under the <u>Equality Act 2010</u>, a person has a disability if they have a physical or mental impairment which has a substantial and long-term effect on their ability to carry out normal day to day activities.

The Mathematics Teacher Training Scholarship Scheme assures that disabled applicants will be invited to an Assessment who are deemed to meet the following from the Scholarship criteria:

- the wider criteria for becoming a Maths Scholar

The wider criteria for becoming a Maths Scholar is assessed by the personal statement, which has its own specific requirements.
